Director's Reports - November 2021-October 2022

President's Report – Jason Hassey

I would like to thank all of our executives, directors and all other volunteers for their hardwork and dedication to making this past field and box lacrosse season a success. Without all of you none of this would be possible.

My first year holding the president's position was challenging as our association was looking forward to navigating the first season after covid-19. Unfortunately, player registrations were down this year. However, it was an exciting season seeing our young athletes hitting the field and floor for the past field and box season.

Field lacrosse

We were able to declare a U15 team who had a successful season despite the extreme weather throughout the season and capped the season off with a strong showing at provincials. All field registrants in the other age groups were released to neighbouring associations.

Box Lacrosse

We declared U6(Mini Tyke), U10(Novice) and U12(Peewee) teams. Unfortunately, we were unable to field a team in U8(Tyke), U14(Bantam) and U16(Midget) divisions. U14 and U16 players were released to a neighbouring association. Our U6 team was invited to play games hosted by Nanaimo.

Moving forward we will continue to plan for the upcoming lacrosse season and continue to grow the game of lacrosse in our community.

Respectfully, Jason Hassey, President 2021/22 Grateful for the opportunity to serve in these roles again for the 3rd year with OMLA, particularly for the 1st "normal" season we experienced since 2019. This year again marked a time of transition with Jason O'Connell passing the president's torch to Jason Hassey. We were pleased to be able to reintroduce our pre-season try-it and rust remover sessions in Feb/March, in addition to participating with the RDN on an introduction to lacrosse session for younger players. Additionally, we were able to host a coach's session, welcoming at least three new coaches to the roster as re-opening saw registrations begin to grow again. Financially we were able to offer regular season programming, and gradually expand programs offerings once again (, thanks to the generous support of the province (ViaSport and Community Gaming Branch) and Canadian Tire Jumpstart, such as supplying sticks for first time players, offering reduced registration fees for the first child of head coaches, and continuing to encourage youth to be involved in refereeing. Unfortunately, we did not have adequate resources to be able to offer our Shark Attack tournament in 2022, hope to be able to resource this signature tournament again during the 22/23 season. Operating Policy updates and that had been ratified in November of 2020, along with insights from a strategic planning session in September of 21 strategic were successfully implemented and integrated, helping us streamline operations and work with our partner associations most effectively. We worked with Nanaimo Raiders and Alberni Valley Lacrosse (with the support of The VIYFLL & VIMLC) to ensure opportunities for all those players who wanted to be on the field or at the box this past season were accommodated. Special thanks to the RDN (and happy retirement to Debbie Couturier!) who have always ensured our timely and safe access to facilities and coordination with other groups. We continued consultation with City of Parksville of Parksville to ensure continued and safe access to the Community Box, an essential facility for our Association, and look forward to working with them and other recreational groups in the coming months to expand an improve that facility.

After 2 years of COVID restrictions and limited games it was great to see a regular lacrosse season in 2022! Following are the box registration totals by division:


